## WFEC Board officers elected for 2022-23

ew officers for Western Farmers Electric Cooperative's (WFEC) Board of Trustees, for the upcoming year, were elected during an Organizational Meeting, hosted Wednesday, April 20 at the cooperative's Moore Office. This meeting followed the Annual Meeting of Members, which was preceded by the regular monthly Board of Trustee meeting.

Nominations for Board trustees and alternate Board trustees were also approved during this session, with several new members welcomed to WFEC's Board.

Donnie Bidegain, who was re-elected as president for the Board of Trustees, explained that a primary focus of the Board is to promote reliability without rising costs to members. "This focus is important as we navigate through the ever-changing, fast-paced industry," he pointed out.
